Jon 'Trickshot' Wilson passed away due to complications from this virus. It broke my heart to hear that news and still brings the emotions to the surface as I write this.


My first dealings with Trickshot was over some Facebook posts and to be honest we kind of got into it online a few times over various things he would post.
